



## Watercraft Registration Form

The privilege of boating in the Water Valley community comes with an agreement to adhere to the detailed Rules and Regulations within the Amenities Use Policy. Residents and/or their guests are independently responsible for understanding these rules and assume all risks of injury to person or property inherent to the lakes, beaches, recreation facilities, and of boating activities. It is the right of PTMD to suspend the use of facilities for non-adherence.

- Boats are not permitted to be stored on the beaches unless an approved boat storage sticker is purchased. Space is limited and stickers are issued on a first come, first serve basis. Watercraft improperly stored will be subject to confiscation.
- Current Recreation Passes are required and must be carried at all times when operating a watercraft.
- Watercrafts must be registered through the PTMD office.
- Watercraft registration stickers must be adhered on the back-right side of the watercraft, visible above the waterline.
- Use of watercraft after sunset must have running lights for nighttime operation. Noise, voices, and music after dark to be kept at a volume so as not to create a disturbance, or that carries further than 25 feet from the watercraft.
- No boating, fishing or swimming shall be permitted in close proximity to or along the Pelican Lakes Golf Course fairways on Habitat Lake, Rock Bridge Lake or Eagle Lake.
- Watercrafts must be no longer than 24 feet using the U.S. Coast Guard Simplified Measurement System.
- Jet skis and similar personal motorized watercraft are prohibited.
- The speed limit is 5 mph. All watercrafts shall operate at wakeless speeds at all times.
